- Can I fire someone who is
 - Disabled
 - Race, Religion



Non-Compliant Patient

- Can I fire someone non-compliant with meds?
 - Yes, but do it properly.
 - Each state has own rules

- Will I get sued if pt is non-compliant and has bad outcome?
 - Documentation = Defense

- We gave the patient a wrong dose, but they seem fine?
 - Do we document?
 - Do we tell?

YES!





Charting and Documentation

Adverse outcome occurred, how do we chart

We have new information- how to amend record?

- After fact realize incomplete, now what?
 - Consents
 - Progress notes
 - Procedure notes
 - Recognize that all ex post facto charting will be attacked



Timely Completion of Notes

- We have a doctor who left (or just refuses) and multiple charts note completed, now what?
 - Always best to persuade
 - Unprofessional- reporting
 - Withhold money
 - How notify patients?
 - How alert future providers?
 - Billing?





Disclosure Adverse Outcome

- How do I disclose an adverse outcome?
 - Discussions and scripting/practice
 - Areas of Concern
 - Admissions
 - Incident Reporting to Copic
 - 3R's
 - Candor
 - Atty



Semaglutides

 - Scope of practice
 - Relationship
 - All aspects of care present
 - Consents

 Can we sell compounded semaglutides?

Ancillary Services and Supervision


- I want to get involved with:
