# FAQs for Online Payments Through Copic's Website

## How do I pay my bill online?


Go to www.copic.com and click Login on the upper right under Customer Portal.



Then enter your email address and password and you will be taken to the Customer Portal.




Once you are on the main dashboard page of the Customer Portal, you can select the Billing option on the left side navigation.





PLEASE NOTE: Since Copic moved over to its new website in August 2024, all users need to update their login credentials (if they haven't done so already). If you need to reset your login information, please contact Customer Support at 720.858.6160 or customersupport@copic.com.



## What activities can I do in the billing section?

- View statements and paid invoices
- Set up Auto-Pay
  - Auto-Pay is a convenient option through which bills will be paid automatically each billing cycle on their due dates using your default credit card or bank account.
  - o The Auto-Pay date will not appear on the home page under Upcoming Scheduled Payments. However, when on the Scheduled Payments page, Auto-Pay will show.
- Schedule payments
  - Scheduled payments are one-time payments that are scheduled for a specific date prior to the bill due date.
     The date of a scheduled payment can be changed as long as it is adjusted before the date scheduled.
- Update your payment method
  - O You can pay with credit or debit card or you may issue an electronic check from your bank account (checking or savings). You can use any combination of payment types per transaction. Note that credit card payments are limited to \$25,000 per transaction.

## Can I tell if my payment has been posted?

Yes, log in to your account and select "Paid Invoices." Your payment will post immediately.

# If I sign up to go paperless, how will I receive my bills?

You will receive an email notification each time a new bill is ready for you to view and pay. In addition, you will receive an email reminder as your due date approaches and if it becomes past due. You can also print a copy of your bill for your records.

# How will I know that my payment has been accepted?

After you submit your payment, you will see a payment confirmation screen. You will also receive a confirmation email after your transaction is submitted. If your electronic check does not pass through the bank, you will receive an email informing you of the rejected payment.


# How long does it take for online payments to process?

Credit card transactions are authorized immediately and typically take 48 hours to settle. Electronic checks typically take 48–72 hours to settle.

Patient safety is a top priority, and when care breaks down in our fragmented healthcare system it can lead to serious issues like readmissions, missed diagnoses, medication errors, delayed treatments, and unnecessary tests and procedures. These problems not only reduce the quality of care but also cause frustration for both patients and providers.

Copic Medical Foundation is committed to finding solutions to these challenges. We support initiatives that can be scaled or replicated, focusing on testing new ideas and expanding existing solutions to make a broader impact.

We're thrilled to announce the 2025 cohort of grant recipients. This year we're supporting six diverse organizations making a difference in healthcare across the country. Copic Medical Foundation has awarded over \$950,000 in grants to these recipients:

# Children's Hospital Colorado Foundation (Colorado)

Children's Hospital Colorado Foundation is expanding its Transition Care Management program to serve more children by building interdisciplinary teams that address postdischarge challenges and improve outcomes for medically complex and underserved patients.

# Children's National Medical Center (Pharm-PATHS) (Washington, DC)

Children's National Medical Center is studying Pharm-PATHS, a pharmacist-led telehealth intervention designed to improve medication safety at home for children with medical complexity and reduce care fragmentation.

## University of Nebraska Foundation (on behalf of Nebraska Medicine Innovation Design Unit) (Nebraska)

The University of Nebraska Foundation is piloting a regional virtual nursing program to improve care coordination, support staff, and establish a model for expanding virtual care across the region.

### Stigler Health & Wellness Center (Oklahoma)

The HWC Continuing Care Program will provide patients who have recently had a hospital or emergency department visit with in-home nursing visits and telehealth consultations. This program ensures patients understand treatment goals, have necessary supplies and resources, and receive timely visits, especially for those with serious conditions, to manage ongoing issues effectively.

### St. Mary's Health Clinics (Minnesota)

St. Mary's Health Clinics is implementing the Community Health Empowerment Initiative to reduce care fragmentation for 1,200 uninsured, Spanish-speaking immigrants through bilingual health workers, medication management, and culturally tailored education.

# Nebraska Hospice and Palliative Care Association (Nebraska)

Implement the MyDirectives platform as a statewide advance care planning document (ACP) registry to streamline access to ACP documents.

We hope that attendees left the event with new ideas, new partners, and fresh perspectives to enhance their efforts in advancing patient safety on a larger scale.

# The Legislative Landscape

The Colorado General Assembly adjourned on May 7, 2025. The dynamics of a new presidential administration, a term-limited governor, and a very active state legislature made for an eventful legislative session.

The state legislature debated more than 600 bills at the capitol during the 120-day session. Governor Jared Polis has until June 6 to sign or veto bills or let them become law without his signature. Below are a few passed bills that the Copic team would like to highlight:



## Safeguarding Against Frivolous Lawsuits

After pushback from a large bipartisan group of legislators, Senate Bill 157 failed to pass the Senate. The bill, titled "Deceptive Trade Practices Significant Impact Test," would have removed the significant impact requirement from the Colorado Consumer Protection Act (CCPA). The requirement in current law is that to bring a CCPA claim, there must be proof that a deceptive trade practice occurred in dealing with the public, significantly impacting the public as actual or potential consumers. Doing away with this test would have meant more lawsuits against the greater business community, including healthcare providers.

### What does this mean for you?

The Copic team has consistently opposed this bill on behalf of our insureds. We recognize that a more litigious environment would impact access to healthcare, especially in rural and underserved areas.



## Providing Emergency Medical Services

Senate Bill 130 was the legislature's move to preserve the Emergency Medical Treatment and Active Labor Act (EMTALA) in state law, particularly the Biden administrative guidance clarifying that abortion care is included within the required services when it is necessary to stabilize the patient, should the federal law be repealed. The bill is a response to concerns that the new administration may repeal the abortion care protections added to EMTALA in 2022. The Copic team engaged alongside our colleagues at the Colorado Medical Society and Colorado Hospital Association, among others to provide draft language to this bill.

#### What does this mean for you?

The final version of the bill aligns with federal standards and we anticipate little impact on requirements for providers.



## Provider Confidentiality in Licensing Applications

House Bill 1176, titled "Behavioral Health Treatment Stigma for Providers," is headed to the governor's desk for signature. The bill clarifies that an individual who is subject to the licensing requirements of the Colorado Medical Practice Act is not required to disclose a physical illness, physical condition, behavioral health disorder, mental health disorder, or substance use disorder that no longer impacts the individual's ability to practice their respective healthcare profession or occupation with reasonable skill and safety to patients or clients.

#### What does this mean for you?

This legislation has been adopted in 29 other states and seeks to address provider mental health. This legislation attempts to support physicians seeking, who have sought, or want to seek care by removing questions that stigmatize such care on a healthcare provider's licensure application and renewal questionnaire. The legislation clarifies that providers are not required to disclose personal medical or health information that is not relevant to the applicant's current ability to provide safe and ethical patient care. However, the bill also clarifies that a healthcare professional **must** additionally provide notice of a substance use disorder and specifies that the healthcare professional is only required to provide notice of a current condition. The bill defines "current" as recently enough to justify a reasonable belief that a health-related condition may have an ongoing impact on an individual's ability to practice medicine.

- Senate Bill 152 Healthcare Practitioner Identification Requirements

- Senate Bill 290 Stabilization Payments for Safety Net Providers
- House Bill 1024 Requiring a medical professional to disclose certain information to patients if the medical professional delegates medical-aesthetic services to an individual who is not a licensed healthcare provider
- House Bill 1063 Lawful use of crystalline polymorph psilocybin that is approved by the United States Food and Drug Administration
- House Bill 1070 Conditions when electroconvulsive treatment may be performed on a minor
- House Bill 1270 Patient's Right to Try Individualized Treatments

# Doc2Doc Wellbeing Consulting Program

The Colorado Physician Health Program (CPHP) is a **confidential and free** resource to help all medically licensed professionals in Colorado. CPHP provides true peer support (physician to physician) for all health problems and wellbeing issues such as burnout, stress from the workplace, a bad outcome or malpractice case, depression, anxiety, substance related issues, and chronic illness. CPHP provides evaluation, treatment referral, monitoring, and supportive services to safeguard your best health and wellbeing.

CPHP's latest offering, in collaboration with the Colorado Medical Society, is the Doc2Doc Wellbeing Consulting Program where Colorado medically licensed professionals may access brief impactful consultation related to one's health or wellbeing by a physician peer expert, bypassing lengthy documentation or evaluation. This service is geared especially for burnout but can assist all professionals who just need a peer to talk with. This program is free and confidential.

Copic and CPHP know that healthy doctors give better care. See our collaborative research here: **pubmed.ncbi.nlm.nih. gov/23606266/**. This study demonstrates that treatment and monitoring at CPHP is associated with a lowered risk of malpractice claims and suggests that patient care may be improved with monitoring.











# The Legislative Landscape

The lowa Legislature adjourned at 6:30am on May 15 after a 21-hour final legislative day. The budgeted per diem for legislators ran out on May 2, so the session went 13 days overtime and unpaid! The session was full of activity, sending 147 bills to the governor's desk for signature into law. Keep reading for your legislative update below.

Governor Kim Reynolds, who has been in office since 2017, announced that she will not be seeking a third term in 2026. Governor Reynolds is the state's first female governor and has worked to make healthcare more affordable and available in the state, including championing non-economic damage cap legislation in 2023.

### What didn't make the cut?

The Copic team tracked about 90 bills in the Iowa legislature this session. Of the priority bills, the following did not make it through the legislative process this year, but we expect to see these bills resurface next session.

- Senate File 180 The right to refuse certain medical services for reasons of conscience
- House Study Bill 210 Relating to medical liability claims, including certificate of merit affidavits
- Senate File 586 Regulating litigation financing contracts.

## **Improving Rural Healthcare Access**

In a win for healthcare access and delivery in rural areas of the state, House File 972 was sent to the governor's desk on May 13 for signature into law. The bill was the governor's headline initiative this session and aims to make significant investments in lowa's rural physician workforce. House File 972 makes record-level investments in the physician workforce by increasing general medical education (GME) residency slots, strengthening maternal health services, and nearly doubling funds for healthcare loan repayment programs. The toplines of the bill include:

- Draws down \$150 million in federal funds for GME residency training slots, creating 460 new positions over four years;
- Increases funding to \$8 million for rural healthcare provider loan repayment and consolidates existing programs for greater flexibility;
- Invests \$640,000 for unbundled Medicaid maternal health rates; and
- Invests \$1 million for research into lowa's high cancer rates.

#### What does this mean for you?

This bill has been applauded by our partners at the lowa Medical Society and Iowa Hospital Association. The Copic team is proud to insure many rural healthcare providers, and hope these resources benefit recruitment to your practices and ensure access to quality care in your community.

Copic and the Iowa Medical Society (IMS) are proud to announce that Dr. Elaine Berry is the 2025 recipient of the IMS/Copic Physician Humanitarian Award. Dr. Berry is a Cass County-based physician who is board certified in both family medicine and hospice/palliative care. Over the

years, she has demonstrated an unwavering commitment to excellence, professionalism, and the dignity of every person she encounters.

Dr. Berry has been a pillar of her community since she began her career at Cass Health in 1988. Through 2022, she worked as a family medicine physician primarily at Atlantic Medical Center, but also in satellite clinics in Griswold and Massena. You could often find her making rounds on the inpatient floor providing care to her patients or helping in the Emergency Department.

Dr. Berry also served as the Medical Director of UnityPoint at Home (formerly Cass County Home Care/Hospice). Patients, families, and other physicians regularly turned to her for guidance on managing end-of-life care for patients. Compassionate with all her patients, she has a special commitment to ensuring

patients end their journey with dignity and respect.

Her other roles included Cass County Medical Examiner, Medical Director for Emergency Services, Hospice Medical Director, and her current position as Chief Medical Officer at Cass Health. She has been instrumental in disaster preparedness, EMS advocacy, and mentoring future medical professionals. Dr. Berry has also participated in medical mission trips to countries like Egypt, India, and Honduras, and has supported newly immigrated families in her church community.

Each year, the recipient of this award is asked to designate a \$10,000 donation from Copic to be provided

to a healthcare-related nonprofit organization within their community. Dr. Berry has designated Cass Health Foundation to receive this donation, specifically to support the Nurse Apprenticeship program, an innovative initiative to train nurses and address the healthcare workforce shortage.

# The Legislative Landscape

The Nebraska Legislature is scheduled to adjourn on or before June 9, 2025. The legislature is allowed by the state constitution to meet up to 90 days of normal business in odd-numbered years, but in the world of politics, "normal" may be tough to define!

Governor Jim Pillen is up for re-election in 2026. We anticipate that his team will be ramping up campaign activity over the next year, which includes racking up some political wins. The Copic team will keep a close eye on his agenda.

At the time of this publication, 136 bills have passed out of the legislature and are headed to Governor Pillen's desk for signature into law. As a reminder, bills that are not passed this year can be carried forward to 2026 alongside any new legislation that is introduced. While there have been a significant number of healthcare-related bills introduced this session, two major pieces of legislation dominated this year.

### New Regulatory Framework for Medical Marijuana

Nebraskans voted in favor of legalizing medical cannabis (MMJ) in last November's election by way of ballot initiative. Following the vote, the legislature began work to codify how MMJ would be regulated with the introduction of Senator Ben Hansen's "Nebraska Medical Cannabis Regulation Act." This new law would have established the Nebraska Medical Cannabis Commission, a new regulatory body to provide oversight over the rules and guidance for MMJ. Nebraska's Attorney General Mike Hilgers released a statement against the legislation earlier this month, informing legislators of an ongoing lawsuit challenging the validity of the initiative and citing concerns that the legislation is a pathway to recreational use of MMJ. In a late session development, the bill died eight days before the legislature adjourned. However, Governor Pillen has committed to faithfully execute the will of the voters who approved the ballot initiative, stating that the petition did create a Cannabis Commission to regulate MMJ and there is no reason for the leaislature to intervene. The timing on the formation and rules of the commission remains to be determined.

### What does this mean for you?

Copic has weighed in with our partners on the regulatory framework and best practices for physicians using our experience in other states that have passed such laws or initiatives. We advised throughout the bill drafting process, recommending that an established physician-patient relationship exist prior to a referral for MMJ, providing guidance on the process for referrals, and supporting physician immunity. Now that a regulatory framework is not in place for referrals for MMJ, it could lead to increased liability for healthcare providers. Stay tuned for more information.

## **Midwives Scope of Practice**

The midwives made a push for licensure this session, with the introduction of both the "Licensed Midwives Practice Act," which licenses direct-entry midwives and a separate bill allowing certified nurse midwives to practice independently. The Nebraska Medical Association led the effort to negotiate on a variety of topics including a cap on damages, licensure pathways, and the implications of adding certified nurse midwives to the state's Excess Liability Fund.

### What does this mean for you?

While Copic does not normally engage on scope of practice issues, nor do we provide coverage for independently practicing certified nurse midwives, or any provider delivering home births, we did work to inform language related to liability if a patient is transferred to a hospital emergency room after receiving such care. We continue to monitor the legislation as amendments are discussed.
